Dual Licensure Supervision

The expectations for new clinicians coming into the field are ever changing and as supervisors, we must change and adjust with it. It is our responsibility to support our supervisees to ensure they have the skills needed to serve their clients appropriately. One of these changes is the desire to become dually licensed with mental health and substance use licensure as well as additional specific specialty treatment skills.
